Wu Yibing joined Temasek in 2013 and is currently Head, China.

Yibing was most recently Chairman and CEO of Goldstone Investment Co. Ltd., the direct investment arm of CITIC Securities, and concurrently, President of CITIC Private Equity Funds Management, a position he held from December 2009.

Yibing began his career with McKinsey, rising to become Senior Partner and Head of Asia Pacific M&A Practice. He was also General Manager of McKinsey Beijing, where he was responsible for providing M&A, corporate restructuring and IPO advisory for large Chinese enterprises. He advised a number of leading Asian companies in their international expansion efforts. He subsequently joined the Lenovo Group, and led the acquisition and integration of the IBM PC business, serving as Chief Strategy Officer, Chief Integration Officer, and Chief Transformation Officer / Chief Information Officer.

Yibing was later appointed to Lenovo parent Legend Holdings, as Executive Vice President responsible for the overall business operations and overseeing its direct investment business. During his tenure at Legend, he successfully led its equity investments in the financial, energy and consumer sectors, as well as a number of growth capital investments in new energy and high-tech arenas.

Yibing serves on the board of China Social Entrepreneur Foundation.

Yibing holds a PhD in Biochemistry from Harvard University and a BSc in Molecular Biology from University of Science and Technology of China.
