Overview of Temasek

Temasek is an investment company headquartered in Singapore, with offices in 11 cities across the world. (Singapore, China, India, Vietnam, Brazil, Mexico, United Kingdom & United States)

Temasek is wholly-owned by the Singapore Minister for Finance¹. Temasek owns and manages its assets on a commercial basis. Investments, divestments and business decisions are directed by its Board and management.

Temasek's portfolio as at 31 March 2019 was S\$313b (US\$231b²).

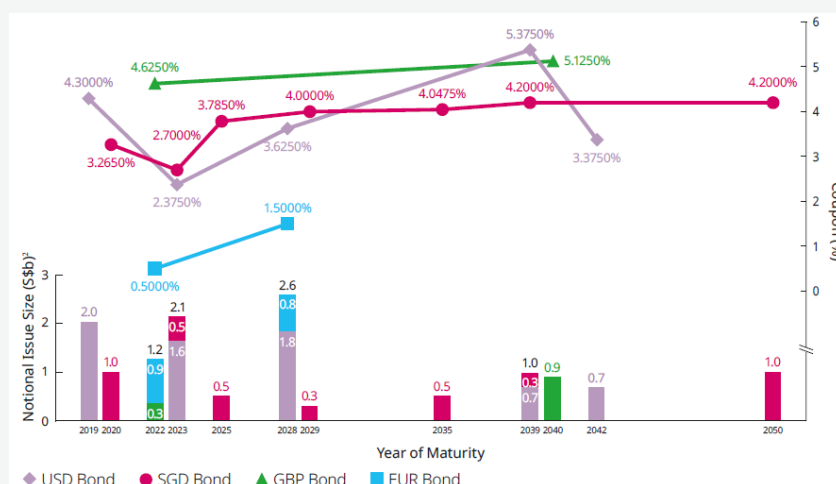

Temasek Bonds

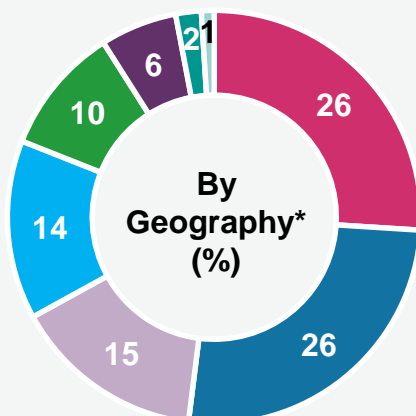
- Temasek Bonds increase Temasek's funding flexibility and expand its stakeholder base to include both international and Singapore bondholders
- As at 31 March 2019, there were S\$13.8b (US\$10.2b²) of Temasek Bonds outstanding, with weighted average maturity of over 10 years



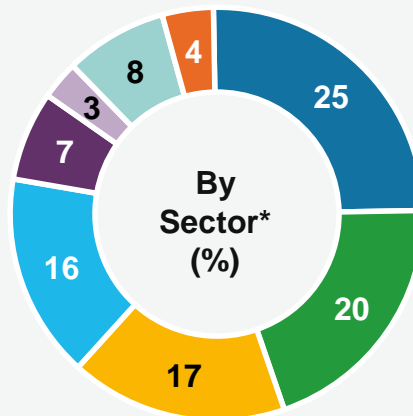

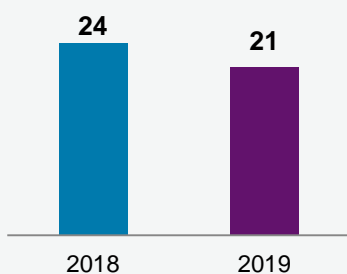

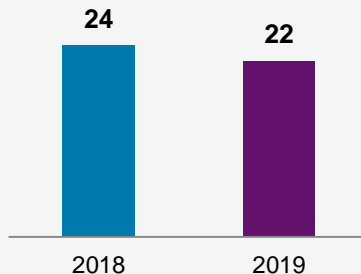

(For year ended 31 March)

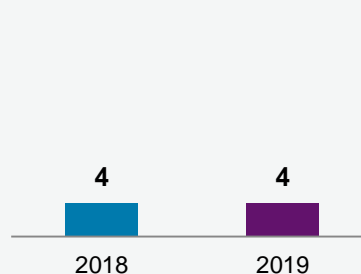
Net Portfolio Value over Total Debt (x)
